Investment focus

BB Biotech invests worldwide in fast growing companies developing and marketing innovative biotech drugs. At least 90% of its shareholdings must be in listed companies, while always holding more than 50% of its assets in equity investments. The target portfolio of BB Biotech will generally consist of 20 to 35 participations. Large positions will be taken in five to eight companies, the top holdings. Together they will account for no more than two-thirds of the portfolio and no single position will have a weighting greater than 25% of portfolio investments. Due to their substantial portfolio weighting, the top holdings should be generating both revenues and income. The portfolio's smaller participations are companies with promising drug candidates in their R&D pipelines. Investments are selected according to a thorough, multi-level due diligence process, with a particular focus placed on the analysis of financial parameters, the respective competitive environment, the development pipeline, the patent portfolio, and end-client perception. ESG factors are taken into consideration while implementing the aforementioned investment objectives.





Market commentary

In May BB Biotech's share price declined by 7.8% in CHF and the Net Asset Value declined by 1.7% in USD. The Nasdaq Biotech Index was down by 2.6% in USD in May.

Many of BB Biotech's portfolio companies reported first quarter results in May and in general the developments both scientifically and financially are advancing according to plan in the companies. BB Biotech's core holdings all reported quarterly results in the beginning of May.

Please find below selected highlights from a few of BB Biotech's portfolio companies:

Argenx (+0.2%, in USD) announced on May 4 its first quarter 2023 results showing total operating income of USD 229.9 mn. Product sales from the company's newly launched Vyvgart (efgartigimod) were USD 218 mn. Argenx aims to solidify its FcRn leadership by expanding the scope of IgG-mediated autoimmune diseases in development and further demonstrating the potential of FcRn blockade in ongoing clinical trials. By the end of 2023 Argenx expects efgartigimod to be approved in regulatory review or in development in 13 severe autoimmune diseases.

lonis (+15.6%, in USD) announced on May 3 its first quarter 2023 results showing revenue coming from diverse sources, with approximately half coming from commercial products and half from numerous partnered programs. Total revenue in the first quarter amounted to USD 131 mn

Vertex Pharmaceuticals (-5.0%, in USD) announced on May 1 its first quarter 2023 results showing that product revenues increased to USD 2.37 bn, primarily driven by strong uptake of Trikafta/Kaftrio in multiple countries and continued performance of Trikafta in the US. On May 3 the company announced that FDA has approved Kalydeco for use in children with cystic fibrosis aged one month to less than four months old who have at least one mutation in their cystic fibrosis transmembrane conductance regulator gene that is responsive to Kalydeco based on clinical and/or in vitro assay data.
